## TAX BILLS

Enclosed are your 2010 Real Estate and/or Personal Property Tax statements. Please take a few minutes to read your tax bill, especially noting the due dates and collection times and locations. The amount of the Lottery Credit is \$85.23 and the First Dollar Credit is \$67.60 for properties located in the Village of Cobb/Iowa-Grant School District this year.

Wisconsin Statute 74.11(12) establishes payment priority so the Personal Property tax bill shall be satisfied <u>first</u>. Any partial payment shall be applied in the following order: 1) personal property tax, 2) special charges --including delinquent water, sewer, garbage and recycling charges, 3) special assessments 4) special taxes, and 5) real estate taxes.

Please submit the payment coupons at the bottom of the bill with your payment to the appropriate tax collecting location. Your first installment or total amount can be paid to the Village of Cobb ON OR BEFORE JANUARY 31, 2011. Payments can be made in person, deposited in the drop slot in the door at the Village Office, and via mail until January 31, 2011. If you have escrow funds, please remember to endorse checks which are payable to the homeowner and the Village of Cobb prior to sending payment. If you choose to pay on the installment plan, the SECOND INSTALLMENT IS DUE BY JULY 31, 2011 AND GOES TO THE IOWA COUNTY TREASURER AT THE COURTHOUSE, 222 N IOWA STREET, STE 101, DODGEVILLE, WI 53533. Any tax that is delinquent shall begin to accrue interest at the rate of 1% per month beginning February 1; part of the month is treated as a full month. Please be aware that reminder notices are not sent out prior to the July 31st payment deadline. Please include a self-addressed, stamped envelope with all mail payments to the Village of Cobb and Iowa County Treasurer for returning a paid receipt.

## OFFICE HOURS FOR COLLECTION

The Village office hours are Monday through Thursday 8:00 a.m. until 4:30 p.m. The Village Office is located at 501 Benson Street. Please see the enclosed schedule for holiday hours. **Also note that the Village office will be open for tax collections on Saturday, January 29<sup>th</sup> from 8:00 a.m. until 12:00 p.m. For your convenience, there is a drop slot in the door at the Village office. You may also mail your tax payments to the Village of Cobb, PO Box 158, Cobb, WI 53526-0158.**

Village Maintenance will be collecting Christmas trees on Wednesday, December 29, 2010 and Wednesday, January 5, 2011, weather permitting. Please place your Christmas tree at the curbside for pickup. Trees must be free of metal tree stands and all ornaments.

# **DOG/CAT LICENSES**

Officer who responds to all calls regarding unlicensed animals and/or any other pet concerns reported. Wisconsin Stats. 174.05 requires that all dogs over five (5) months of age be licensed and Village Ordinance requires that all cats over five (5) months of age also be licensed. Village Ordinance also limits the number of dogs owned to 2 per household. A dog/cat license application is enclosed. Please feel free to copy the form, if needed, contact the Village office for additional forms, or forms are also available on the Village website at <a href="www.villageofcobb.com">www.villageofcobb.com</a>. A <a href="current">current</a> rabies vaccination is required at the time your license is obtained. Rabies vaccination records for dogs/cats licensed in 2010 are in the computer system. <a href="Waccination records are only needed if there is an update from last year or if this is a new animal to be licensed.">waccination records for licensed</a>. The cost of a license is \$10.00 for a neutered male/spayed female dog or cat and \$15.00 for an intact male/female dog or cat. A \$5.00 late fee will be assessed to animals not licensed by April 1, 2011. If you no longer have your dog or cat, please let the Village Office know so we can update our records. Citations will be issued to owners with unlicensed pets. A reminder that all dogs and cats are required to be tied or contained in a proper enclosure at all times. Animal Ordinances will be enforced and residents violating any animal ordinance will be fined by the Iowa County Sheriff's Department. Please be a responsible pet owner and remember to keep all animals in your own yard and properly dispose of waste.

# **How to Make a Winter Survival Kit**

Everyone should carry a Winter Survival Kit in their car. In an emergency, it could save your life and the lives of your passengers.

# Here is what you need:

- a shovel
- windshield scraper and small broom
- flashlight with extra batteries
- battery powered radio
- water
- snack food including energy bars
- raisins and mini candy bars
- matches and small candles
- extra hats, socks and mittens
- First aid kit with pocket knife
- Necessary medications
- blankets or sleeping bag
- tow chain or rope
- road salt, sand, or cat litter for traction
- booster cables
- · emergency flares and reflectors
- fluorescent distress flag and whistle to attract attention
- Cell phone adapter to plug into lighter

# Kit tips:

- Reverse batteries in flashlight to avoid accidental switching and burnout.
- Store items in the passenger compartment in case the trunk is jammed or frozen shut.
- Choose small packages of food that you can eat hot or cold.
