
#### TAX BILLS

Enclosed are your 2019 Real Estate and/or Personal Property Tax statements. Please take a few minutes to read your tax bill, especially noting the due dates and collection times and locations. The amount of the Lottery Credit is \$223.33 and the First Dollar Credit is \$80.49 for properties located in the Village of Cobb/lowa-Grant School District this year.

Wisconsin Statute 74.11(12) establishes payment priority so the Personal Property tax bill shall be satisfied first. Any partial payment shall be applied in the following order: 1) personal property tax, 2) special charges -- including delinquent water, sewer, garbage and recycling charges, 3) special assessments 4) special taxes, and 5) real estate taxes.

Please submit the payment coupons at the bottom of the bill with your payment to the appropriate tax collecting location. Your first installment or total amount can be paid to the Village of Cobb ON OR BEFORE JANUARY 31, 2020. Payments can be made in person, deposited in the drop slot in the door at the Village Office, and via mail until January 31, 2020. If you have escrow funds, please remember to endorse checks which are payable to the homeowner and the Village of Cobb prior to sending payment. If you choose to pay on the installment plan, the SECOND INSTALLMENT IS DUE BY JULY 31, 2020 AND GOES TO THE IOWA COUNTY TREASURER AT THE COURTHOUSE, 222 N IOWA STREET, STE 101, DODGEVILLE, WI 53533. Any tax that is delinquent shall begin to accrue interest at the rate of 1% per month beginning February 1; part of the month is treated as a full month. Please be aware that reminder notices are not sent out prior to the July 31st payment deadline.

If you would like a tax receipt, please include a self-addressed stamped envelope along with your payment!

## **DOG/CAT LICENSES**

pog/cat licenses expire on december 31<sup>st</sup> of Each YEAR... The lowa County Sheriffs Department responds to all calls regarding unlicensed animals and/or any other pet concerns reported. Wisconsin Stats. 174.05 requires that all dogs over five (5) months of age be licensed and Village Ordinance requires that all cats over five (5) months of age also be licensed.

Village Ordinance also limits the number of dogs owned to 2 per household. A dog/cat license application is enclosed. Please feel free to copy the form, if needed, contact the Village office for additional forms, or forms are also available on the Village website at www.villageofcobb.com. A current rabies vaccination is required at the time your license is obtained. Rabies vaccination records for dogs/cats licensed in 2019 are in the computer system. Vaccination records are only needed if there is an update from last year or if this is a new animal to be licensed. The cost of a license is \$10.00 for a neutered male/spayed female dog or cat and \$15.00 for an intact male/female dog or cat. A \$5.00 late fee will be assessed to animals not licensed by April 1, 2020.

If you no longer have your dog or cat, please let the Village Office know so we can update our records. Citations will be issued to owners with unlicensed pets. A reminder that all dogs and cats are required to be tied or contained in a proper enclosure at all times. Animal Ordinances will be enforced and residents violating any animal ordinance will be fined by the lowa County Sheriff's Department.

Please be a responsible pet owner and remember to keep all animals in your own yard and properly dispose of waste.

### **Sidewalks**





The Village ordinance 6-2-7(a) states that in the event of snow accumulating on sidewalks, the sidewalk shall be cleared of all accumulated snow and/or ice within twenty-four (24) from the time the snow ceases to accumulate on said sidewalk. Please help keep your village safe for everyone and take care of your sidewalk. Thank you!



# Cross Connection Information Provided by Wisconsin Rural Water Assoc.

#### What is a Cross Connection?

A cross-connection is an actual or potential connection between the safe drinking water (potable) supply and a source of contamination or pollution. State plumbing codes require approved backflow prevention methods to be installed at every point of potable water connection and use. Cross-Connections must be property protected or eliminated.

#### How does contamination occur?

When you turn on your faucet, you expect the water to be as safe as when it left the treatment plant. However, certain hydraulic conditions left unprotected within your plumbing system may allow hazardous substances to contaminate your own drinking water or even the public water supply.

Water normally slows in one direction. However, under certain conditions, water can actually flow backwards; this is known as Backflow. There are two situations that can cause water to flow backward: backsiphonage and backpressure.

#### Backsiphonage

May occur due to a loss of pressure in the municipal water system during a fire fighting emergency, a water main break or system repair. This creates a siphon in your plumbing system which can draw water out of a sink or bucket and back into your water or the public water system.

#### Backpressure

May be created when a source of pressure (such as a boiler) creates a pressure greater than the pressure supplied from the public water system. This may cause contaminated water to be pushed into your plumbing system through an unprotected cross-connection.

#### Do...

- -Keep the ends of hoses clear of all possible contaminants. -Make sure dishwashers are installed with a proper "air gap" device.
- -Verify and install a simple hose bibb vacuum breaker on all threaded faucets around your home.
- -Make sure water treatment devices such as water softeners have the proper "air gap", which is a minimum of one inch above any drain.

#### Don't...

-Submerge hoses in buckets, pools, tubs, sinks or ponds.
-Use pray attachments without a backflow prevention device.
-Connect waste pipes from water softeners or other treatment systems directly to the sewer or submerged drain pipe. Always be sure there is a one inch "air gap" separation.

#### In the Bathroom – Toilet Tanks

There are many unapproved toilet tank fill valve products sold at common retailers which do not meet the state plumbing code requirements for backflow prevention.

-Look for the ASSE #1002 Standard symbol on the device and packaging -Replace any unapproved devices with an ASSE #1002 approved anti siphon ball-cock assembly. Average cost is typically \$12 to \$22 at home improvement stores.

#### In the Bathroom – Hand Held Shower Fixture

The hand held shower fixture is compliant if:

- When the shower head is hanging freely, it is at least 1" above top of the flood level rim of the tub.
- Complies with ASSE #1014

Wis. Stats. 174.05 requires the owner of a dog more than five (5) months of age on January 1, of any year, or five (5) months of age within a license year to annually pay the dog license tax and obtain a license. Licenses are issued when the Municipal Clerk receives verification of rabies vaccination. Rabies vaccination is important to promote health, safety and general welfare of animals and the people around them.

Village Ordinance 7-1-18(c)(1) states "No family shall own, harbor, or keep in its possession more than two (2) dogs on any residentially zoned lot without the prior approval of the Village Board except that a litter of pups or a portion of a litter may be kept for not more than eight (8) weeks from birth...

Village Ordinance 93-3 states it shall be unlawful for any person in the Village of Cobb to own, harbor, or keep any cat more than five (5) months of age without complying with the provisions of the Ordinance relating to the listing, licensing, and tagging of the same. Same regulations apply for cats as dogs in the Village of Cobb.

Fines for unlicensed animals will be enforced by the Iowa County Humane Officer and the Iowa County Sheriff's Department.
